Systemic social work practice: Collaborating and engaging with families

Clinicians are embedded in teams working alongside social workers, sharing their specialist therapeutic, clinical knowledge and expertise to benefit children and families directly. Clinicians also help frontline practitioners through consultation to keep in mind the part they play in solving problems or reflecting on what we might need to do differently to effect change.

Brighter Futures: Embedding a relationship and trauma-informed practice model in children's services

Brighter Futures is a model which guides practice in Ealing Children's Services. It aims to bring together and integrate key ideas from relationship and trauma-informed theory and practice including; family partnership model, mentalisation-based approaches and dyadic developmental practice (DDP). Supported by embedded clinical psychologists, Brighter Futures supports staff to engage in a partnership and hold empathy for families and young people, whilst recognising the impact of trauma and adversity upon the helping relationship. It puts relationships, between workers, with children and young people, within families, carers and within communities at the centre in facilitating positive change. This seminar will give an overview of Ealing's Brighter Futures Practice model and we'll discuss the successes and challenges in our journey with relationship and trauma-informed practice.

Sibling sexual harm: What social workers need to know

A young person's harmful sexual behaviour can be understood within the context of a number of different factors – including their social, family and developmental history. The young person may need specialist assessment and intervention, combining a range of approaches. The NCATS team is multi-disciplinary, with expertise in social work, clinical psychology, counselling, criminal justice and the Dynamic Maturational Model of Attachment.

In recent years there have been huge advances in our understanding of the effects of trauma, neglect and abuse on a child. These findings have helped confirm what staff in residential settings have been experiencing with such children.

Over 75 years the evolution of The Mulberry Bush School as a therapeutic environment has required an openness to new theories and ideas.

Building an anti-racist workforce doesn't come without challenges and organisations have to be brave enough to do the right thing and find the right language to hold others in mind with respect and humanity. 
